Re: Year 6 Residential Trip to PGL Osmington Bay – Sunday 1st June to Wednesday 4th June 2025

We would like to invite parents to attend a meeting **via Livestorm** on **Wednesday 7th May 2025 at 6.00pm**. The meeting will last approximately 45 minutes and we will give more details about the trip. There will be an opportunity to discuss kit lists and any medical problems.

- **Kit list** – please read through the attached list and ensure your child takes the appropriate items.
- **Medical form** - if your child requires any medication, please complete the attached form and email to: PGL@peartreespring.herts.sch.uk

Forms/consents – please ensure these are all complete **by Monday 19th May 2025**.

On **Sunday 1st June 2025** children and parents will need to meet outside their classroom door at **8.30am**. The front pedestrian gate, by the zebra crossing, will be open from **8.20am**. Coaches will be leaving at approximately **9.00am**. Children will need to bring a home packed lunch (no fizzy drinks or glass bottles please) for the journey to PGL – they will be provided with a hot meal in the evening. Please ensure that your child's packed lunch is provided in a named disposable bag which can be thrown away after.

Children/staff will return from the residential trip on **Wednesday 4th June 2025** at approximately **4.30pm/5.00pm**.

Behaviour Contract – PGL

This contract should be read by parents and children together.

1. During the activity sessions I will follow the directions of the Instructor/Group Leader at all times. I will not do anything to compromise my own or anybody else's safety or enjoyment.
2. I understand that the use of activity equipment during non-supervised sessions is strictly forbidden at all times.
3. My accommodation will be kept clean and tidy at all times. Any damage caused will be reported to my teacher and I understand that I may be asked to pay to have the damage fixed.
4. I will be ready on time for all meals and activities.
5. I will treat all people with respect regardless of race, religion, gender or special educational needs.
6. I will not ridicule any other children and I will offer support and encouragement wherever possible.
7. I will return to my room at the time agreed by my teachers (and stay there) keeping the noise to a minimum at all times.
8. Except in cases of emergency, I will stay in my room until the time agreed by my teachers.
9. I will take care at all times, particularly around other people's rooms and in the dining hall where running and shouting are not allowed.
10. I will at all times follow the Country Code and treat all areas of the Centre with respect. I will take particular care of the woodlands, grass and planted areas.
11. I understand that if the above rules are not kept my parents may be asked to come and take me home.
